# RAVENNA TOWNSHIP BOARD OF TRUSTEES MINUTES OF REGULAR MEETING OF DECEMBER 21, 2015

The Ravenna Township Board of Trustees met in Regular Session at the Ravenna Township Trustee's Meeting Room, 6115 Spring Street, Ravenna, Ohio, on December 21, 2015. Trustee Hank Gibson called the meeting to order at 10:11 A.M. Roll call showed the following present: Trustees Hank Gibson and Vince Coia; Fiscal Officer Gail Pittman; Department Heads Fire Chief Mark Kozak, Zoning Inspector/Liaison Jim DiPaola and Assistant Fiscal Officer Jon Summers. Trustee Pat Artz and Road Superintendent Darrell Stephens were absent. Audience member was Greg Balbierz.

Hank Gibson swore in part time Fire Fighters Stellato and Welch.

#### **AUDIENCE**

Mr. Balbierz, a resident on Birchview, spoke to the meeting about his desire and the desire of the residents around the Birchwood Manor area to develop and grow a public/private, multi faith event in the spring to clean up the community in and around the King Kennedy Center. He discussed the need for the development and enforcement of an exterior maintenance code. He wants to include many of the local organizations in a coordinated and ongoing joint effort. Hank Gibson agreed that many of the properties are in bad shape and in huge need of this type of event. Vince Coia spoke about the mostly unsuccessful prior attempts at coordinating the township clean ups with these neighborhoods. Vince said the date for the upcoming spring cleanup will be set sometime in January.

A motion by Vince Coia, seconded by Hank Gibson to approve the minutes of the Regular Meeting of December 8, 2015. R/C: Mr. Coia, yes; Mr. Gibson, yes. Motion Passed.

Hank Gibson announced the correspondence book was present and available for public viewing.

A motion by Vince Coia, seconded by Hank Gibson to approve payroll warrants for December 24, 2015 in the amount of \$30,654.37 and other warrants in the amount of \$41,404.77 with warrants over \$1,000.00 read aloud. R/C: Mr. Coia, yes; Mr. Gibson, yes. Motion Passed.

# TRUSTEES

A request was received from Steve Parks of the Portage County Engineer's Office to amend the resolution related to vacating the property on Garfield Rd as two of the lot numbers were listed incorrectly.

Fiscal Officer Gail Pittman was present and reported the following:

Financial reports has been distributed to the Trustees and department heads in Excel spreadsheets.

Certified election results for the levies were received from the Board of Elections and there are no changes from the preliminary results.

# DEPARTMENTAL REPORTS ROAD DEPARTMENT

Road Supervisor Darrell Stephens was absent. Vince Coia reported the following:

The County approved the stop sign on Foxwood Drive and Darrell will coordinate placing the stop sign.

Portage County Engineer's Office sent the final bill for our portion of the cost of the sidewalk on Prospect St. Our local match is about \$7,000 less than estimated.

# **ZONING DEPARTMENT**

Zoning Inspector/Liaison Jim DiPaola was present and reported the following:

The property owners at 7635 Cooley Road and 3291 Rose were sent letters from the Prosecutor's Office advising them to correct the violations or they will be cited into Common Pleas Court. They have 14 days to comply.

The property owner of 3886 Summit, Ms. Lynn Lombardi, contacted the Zoning to state she had cleaned up her rental. An inspection showed the violations were corrected.

#### **LIAISON**

Jim is working with the Fire Chief on a grievance filed by one of the fire fighters.

Jim attended a meeting with the Fire Chief and Portage County Water Resources on the proposed water line and fire hydrant locations. We will need to coordinate with Darrell in next year's widening of Dawley Road so we aren't digging up the area twice. Upon completion of the water line project, the residents should be notified to contact their homeowner insurance brokers about a reduction of their insurance rates.

## FIRE DEPARTMENT

*Fire Chief Mark Kozak was present and reported the following:* 

The gear washer should get installed this week.

Gail and Pat have both passed their NIMS certification. We only have two more left to do. Vince will do his this week and Hank is planning on completing his upon his return next week.

The annual filing of the Volunteer Fire Fighters' Dependents Fund elections is due.
