The Ravenna Township Board of Trustees met in Regular Session at the Ravenna Township Trustee's Meeting Room, 6115 Spring Street, Ravenna, Ohio, on August 30, 2016. Trustee Vince Coia called the meeting to order at 7:02 P.M. There is a meeting scheduled on September 8, 2016 at the King Kennedy Center at 5:30 pm to figure out what can be done and Bea invited the Trustees to attend. Pat said her understanding was that the EPA controls what you can and can't do to the wetlands, but she would attend the meeting.

DEPARTMENTAL REPORTS ROAD DEPARTMENT

Road Supervisor Darrell Stephens was absent and Vince Coia reported the following:

We've received the Notice to Proceed for the Dawley Road project. Darrell is having a preconstruction meeting tomorrow with the engineers and Barbicas.

The brush mower on the Bobcat has a hydraulic leak and Darrell is getting a quote to repair it. Vince wants it fixed ASAP so the lot on Brady Lake Rd can be mowed before the Balloon A-Fair. Gail said there was a PO in the list to cover the repair of the Bobcat.

ZONING DEPARTMENT

Zoning Inspector/Liaison Jim DiPaola was absent and there was no report.

FIRE DEPARTMENT

Fire Chief Mark Kozak was present and reported the following:

The contract for Dispatch is still pending and will be expiring at the end of December. Something should be known about it sometime in September.

The fair didn't produce any new interest in the free smoke detectors.

The BWC grant is still pending. We should know more by the end of the week.

Mark would like to buy a HIPAA compliance package. The cost is \$475 and there is a definite need for it. Both Vince and Pat agreed and Gail said there is a BC already out there to cover the cost and we would just need a requisition. They told Jon to go ahead and order it online.

The grass truck is in need of a lot of repairs. Mark questioned whether they wanted to put any more money into the old truck. He said they do need a chase vehicle that the firefighters could use, but any vehicle would be OK, it didn't have to be a truck. The Trustees discussed it and agreed they didn't want to put any more money into the old truck. They authorized Mark to investigate other vehicles. In the meantime, there is no third vehicle for the firefighters to use.
