## New Business: BZA #2023-009

The Board heard from Linda Nikols, owner of Graphics Expressions and U-Haul Rentals, requesting a conditional use permit to operate two businesses at one location, 3097 State Route 59, Ravenna, Ohio 44266. Linda advised the Board that there would be no changes in lighting, security, or parking while adding the U-Haul rental business to this location. She currently has security cameras in place and an ample amount of lighting. Linda also advised that she keeps under 12 U-Haul units, this includes trucks and trailers on her lot at one given time and if any of them are not mechanically ready to rent they will be sent back to the U-Haul traffic department for repairs.

## New Business: BZA #2023-010

The Board heard from Glen Peters, owner of 3336 Summit Road, Ravenna, Ohio 44266 requesting a conditional use permit to operate two businesses at one location. Glen advised the Board that he currently has a residential/day program for individuals with disabilities called, Teammates Center and would also like to lease the building to Passion Community Church to hold services on Sunday morning and a few holidays a year. Glen advised there were no structural alterations inside or outside of this property. Glen was unsure of the building capacity, however stated that there are fire extinguishers, exit signs and exit maps properly posted. Glen advised the Board that there will be no interaction with the general population and the clients of Teammates Center.

Cory DelSavio spoke to the Board on behalf of Passion Community Church. This church has been in operation for 20 years and has always rented a building to hold their services. Cory advised the Board that they have approximately 50 parishioners every Sunday, that they range in age between 40-50 years old, that he has retained a company to plow the parking lot in the winter for safety purpose and, that the restroom capacity is adequate for the congregation.
