<u>BZA #2024-011</u> The Board heard from Kevin McMicheal, applicant Davis Golias' son in law who was requesting a 28'x32' garage to be erected in front of the existing principal dwelling located at 3897 Dawley Road, Ravenna, Ohio 44266.

The main reason for the front yard request is due to the placement of the well, septic and leach beds on this property, heavy equipment cannot be used, and structures cannot be built.

Kevin provided the Board with adequate site plan drawings of this structure. There is a 10'x16' shed on parcel that will be relocated once trees have been cleared. This proposed structure will be a pole barn style, vinyl siding that will match the dwelling, and a concrete floor. There will be no utilities to proposed structure, if needed in future, he may go will solar panels for power. It was stated that there will be a gravel drive, structure will have gutters with proper run-off.

BZA #2024-012 The Board heard from Cody Hager of 4678 Hayes Road, Ravenna, Ohio 44266 who was requesting to erect a 30'x50' pole barn which exceeds the permitted size per the Township Zoning Code.

Cody explained to the Board that there is an existing 20'x20' shed on the property that will be demolished as it is in extreme disrepair. The requested pole barn is strictly for storage, it will have two garage doors with a man door in between and have gray metal siding with white accents to match the house. There will be gutters installed and the way the land slopes to the back, there will be no issues with runoff. He also stated that the proposed building will not be taller than the dwelling.

James Edwards, a neighbor who owns the parcel behind Cody spoke in favor of the pole barn. He stated that the water will run off into the wooded land and there will be no issues with that. James also stated his son has had a 30'x60' pole barn on his parcel for over 30yrs.

Claire made a motion to approve BZA #2024-012 with the following conditions, the peak of the pole barn cannot be higher than house, the existing 20'x20' shed needs removed and there must be proper water runoff.
